The National Medical Commission, New Delhi has conveyed the Letter of Permission of the Medical Assessment and Rating Board (MARB) for starting of a new Medical College at Ariyalur District, Tamil Nadu in the name and style of "**Government Medical College, Ariyalur**" with an annual intake of One Hundred and Fifty (150) MBBS seats from the academic year 2021-2022 under section 26(1) (a) (b) (c) and 28(1) (2) of the NMC Act, 2019.

In the reference 4th cited, this University has granted **Provisional Affiliation Orders** to **Government Medical College, No.1, College Road, Ariyalur - 621 713** for starting of 1st MBBS Degree Course with an annual intake of 150 seats from the academic year 2021 - 2022 and the same was approved in the Governing Council in its resolution No. 288th (5) held on 31.01.2022.

In the reference 6th cited, the Governing Council in resolution No. 292nd (42) held on 03.08.2022 has resolved to grant CPA/ CCPA for the academic year 2022-23.
